



Bob Pinner

The greatest artworks tell a story, and I like to include some narrative in my work. I like to give a painting a sense of place and space, a context, and a meaning. In painting, I experience the joy of creating; the excitement of discovery; the honor of sharing an auspicious subject; the satisfaction of completion; and a sense of connection with art history. My inspiration comes from a lifetime of travel, visiting museums, concern for the environment, and life experiences. I often find that travel introduces new experiences, subjects and insights for art. I have painted many landscapes, and also portraits of people and animals, with an eye for the location.

If you ask me for my favorite artist, it would be Winslow Homer. I especially like his many narrative scenes. I admire his ability to make one stroke of paint and not go back over it. I also like the colorful expressionists.

Why do I prefer watercolor? It just happens to be what got me started. Any watercolorist loves the way the wet paint flows and blends. I have also migrated into acrylic which gives a more permanent feel but requires much more blending and paint mixing.



I am a retired social worker who took up watercolor painting during my lunch hours at the office. Since then, I have expanded my skills and repertoire by attending adult art classes and professional workshops. I grew up in California and have lived in Hawaii, Colorado, Germany and Italy. I began my association with Foothills Art in 2011 and enjoy the camaraderie of fellow artists that the association provides.

He attended Youngstown State University where he studied art and became fascinated with the French impressionist painter, Paul Cezanne whose studies of nature strongly influenced Paul. Not long after receiving his fine arts degree in painting, Paul moved west to San Diego where he found a climate similar to Cezanne's favorite haunts in southern France.

Board Proposed Change to our Bylaws

Foothills president Scott Trimlett says that, as an all-volunteer organization, our members are eligible for election to our Board as a serving officer. For the purpose of consistency and momentum in our activities, the Board recommends making a change to our bylaws, eliminating term limits thus allowing our Board officers the flexibility to be eligible for re-election and serve more than the current limit of two consecutive years in any given position.

Currently Section 3 of Article VI - Election of Officers states:

"All officers shall be elected annually. No officer shall be eligible for election for more than two consecutive years. The office of the Treasurer shall be exempt from the two year limit

Board Proposal: Change Section 3 of Article VI to read:

"All officers shall be elected annually. Officers shall be eligible for re-election for multiple years of service. However, if an unanticipated need should arise, any such elected Officer may resign or be removed from office, with or without cause, by the vote of a majority of the members present at any regular meeting during which such need has been raised for member consideration."

Board Meeting Minutes (continued from page 6)

3. Debbie and Lee discussed the schedule for this year's Wildlife in Art Show. We will launch a campaign to solicit volunteers to be mentored by the Atkinson's in prepping for next year's show. They explained they are looking for a few protégés to join the Wildlife in Art 2018 team to work with them in planning and executing all administrative details of this year's show. The goal of this work is to have people become knowledgeable and proficient under their tutelage so the new team can coordinate the 2019 show. They explained that while there is no right number of team members' to effectively manage the show, they have found that the tasks can be compartmentalized based on team members' skills, computer knowledge and available time. Possible parsing out functions: Lead Organizer, Jurist Selection Lead, Show Sponsors and Awards Lead, Publicity-show Prospectus Lead. Currently the only part of the Wildlife show funded by the FAA are the award ribbons, historically all other costs have been willingly donated/absorbed by the Atkinson's. Lee will provide a tally of all the expenses/costs they have donated, because such costs in the future will be borne by the FAA.
4. Joshua Gomez of La Mesa Community Services has said that we will be able to hold an Art in the Park Sale at MacArthur Park. We will begin the process of completing forms, provide an up to date business license and listing the City of La Mesa as additionally insured. Our insurance agent stated our current insurance will cover the event. A target date of June 10th has been set. The only feasible way to have food served is via City of La Mesa licensed food trucks. Each artist is to supply their own table/display setup. FAA will need to sign the La Mesa Participant Waiver form on behalf of the FAA when applying for the permit and then have each individual artist sign our La Mesa and FAA Event Participant Waiver form list as a prerequisite to displaying and selling their artwork. La Mesa City Business Licenses will also be needed to be held by each Art in the Park Sale artist participant.
5. Carol Kubie is in the process of setting up member subscribed albums/photos on our FAA website.
6. Scott is working with SD Voyager Magazine to have an article written about FAA "Hidden Gems" artists.
7. Gary is coordinating with Brad Weber, publisher of Discovering My City – La Mesa online magazine and several local newspapers, to have our events and meeting dates published.. Judy will be point person.
8. Linda has coordinated with the La Mesa Courier to publish info from Footnotes and, from time to time, include articles about our artists.
9. Linda sent a Public Service Announcement to the Union Tribune about the Old Masters Show which they included twice in the Union Tribune East County Datebook.
10. Bob set up a co-op method for determining the People's Choice Award for the Old Master's Show. Bob will advise Scott of the winner to be announced at the March membership meeting.
11. Roberta has arranged for Jamie Wright to be our juror of the annual Members Show.
12. It is now time to plan for our Board nominating committee to start operating in March with a proposed Board established in April, and then voted on in May and Board members installed in June.
13. A motion to eliminate the time limitation of a two year period for elected board members, per FAA Bylaws, Article VI, Section 3, Sentence 2 (No officer shall be eligible for election for the same office for more than two consecutive years) was brought before the board by Scott. Roz seconded the motion and board voted to bring the proposal before the general meeting.

The meeting was adjourned at 11:35 pm.

The next board meeting date and time will be April 2 at 10:00 am.
