

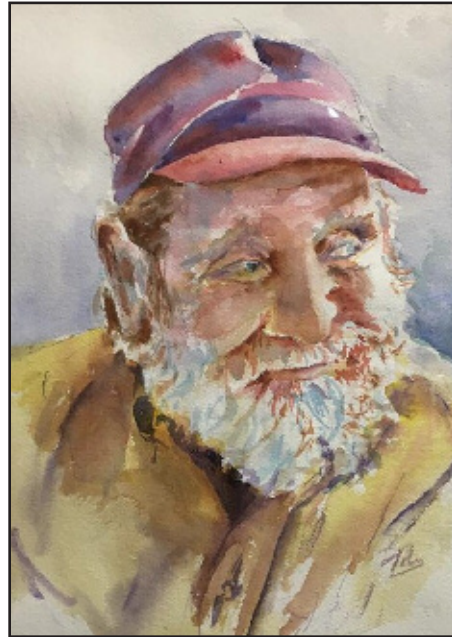

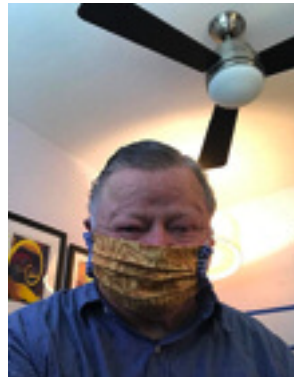

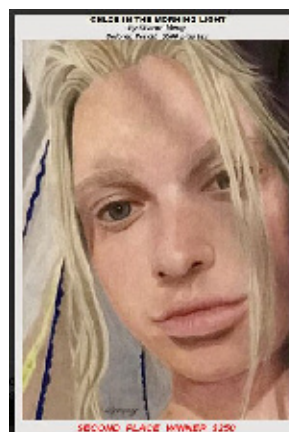
As you may have heard all the works selected for exhibition and the winning pieces selected by Susan Hewitt (our show juror/judge) are available to view in our Gallery through May 5th.

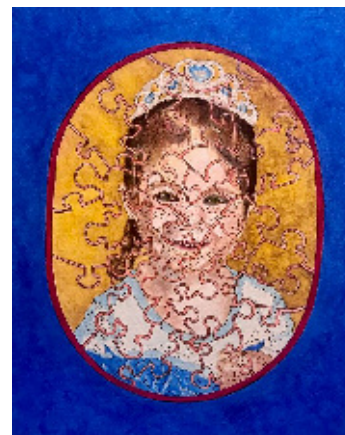

**MINUTES OF THE FOOTHILLS ART ASSOCIATION
APRIL 2021 BOARD MEETING**

The Foothills Art Association Board meeting convened via Zoom Meeting on Monday, April 5th, 2021 at 10:00 a.m.

Attendees: Scott Trimlett, Gary Dyak, Roz Oserin, Bonnie Owen, Rustin Holec, Barbara Drews, Renee Cuifo, Bob Pinner and Roberta Labastida.

1. With San Diego County returning to the Red Covid-19 status and a good portion of our members having received their vaccinations we opened our doors (on a limited basis) to the Gallery on Friday, April 2nd and we are set with Gallery sitters for the whole month.
2. The Annual Members Show had a total of 68 entries. The gross amount received from the entries was \$1080.00. Considering the show awards and the Juror fee expenses it was a very close to breakeven event.
3. The Board will begin creating guidelines for acceptable works that will be incorporated into the rules governing monthly exhibits for new media, e.g., digital art, collage, etc.
4. In April, we are fortunate to have Gabriel Stockton as our featured artist.
5. In order to move to a higher level of ADA compliance we need to take on an initiative to add “Alt text” descriptions to each of our photos contained in our website background and exhibits. This is not insurmountable to accomplish, but we have 65 pages in our website media files that need to be revised to include the required “Alt text” statement that can be read to visitors using a device available to sight impaired visitors.
6. A discussion on how and what we want to do for this year’s Wildlife in Art show was tabled until the May Board meeting.

The next Foothills Art Association board meeting will be held May 3rd, 2021 at 10:00 a.m. via Zoom.

The meeting ended at 10:40 a.m.
